Utah Division of Wildlife Resources land notice of land acquisition

Therese Meyer, Wildlife Realty Specialist, and Bill James, Assistant Habitat Section Chief, Utah Division of Wildlife Resources (UDWR), arrived for their presentation of UDWR's acquisition of two parcels of land in Davis County. They explained both properties are adjacent to the existing Farmington Bay Waterfowl Management Area and have been in state ownership by other state agencies for the past ten years. Both properties were purchased as wetland mitigation for the construction of the Station Park Frontrunner Station. The "Wilcox" property has been owned for the past 10 years by Utah Transit Authority. The "Shepard Lane" property has been owned by the Utah Department of Transportation for the past 10 years. Both properties received 404 permits from the Army Corps of Engineers and will be retained by the Utah Division of Wildlife Resources and managed for wildlife and wetland habitat.

Comments

Commissioner Smith commented that he spent several days last week in a training session for the National Association for Local Boards of Health (NALBOH). This morning he met with the Davis County Board of Health. He feels working with the local Board is one of his favorite parts of his job as commissioner. He very much appreciates all those who work with the health organizations. One of the quotes that impressed him is: "It's hard to market how good a job you are doing because when we do our job really well, nothing happens." He said when you work in public health, nothing happening is a wonderful outcome.

He suggested we need to support our team a little more in their roles as the chief health strategists in our communities. Doctors take care of when you are sick, but the Board of Health is doing the strategy that is keeping us from getting sick.

The last speaker at the Conference said there are disparities. If the definition of public health is the health outcomes of a given population, it also includes the distribution of those outcomes within the group. Just to say that Davis County is a good, healthy county ignores the fact that we have some areas that maybe don't have those kinds of blessings. He surmised, "Zip code affects our health more than our genetic code." Unfortunately, there are some areas where social determinates of health really create serious problems with our citizens. We can't put our heads underground and pretend that we don't have some issues. In the United States, the richest men outlive the poorest men by nearly 15 years. The richest women outlive the poorest women by 10 years and women outlive men. There are all kinds of things that have no genetic determinates.

We are working to equalize some of these disproportionate outcomes. He said the conference also included discussions regarding the opioid problems and legalization of marijuana. He said he has still not found a state that has legalized marijuana that are happy that they did.

Commissioner Milburn commented on the Tour of Utah event that occurred August 4<sup>th</sup>. “We had the opportunity to host Stage 5 starting in Layton and ending in Bountiful. For those who haven’t taken the opportunity to watch the race, you are missing out. These great athletes are nothing but legs and lungs. Davis County is in essence a 115-mile stadium to the world during this event [as it is televised]. All those involved are astounded by what we are able to do here in Davis County. Hats off to Layton City at the start and Bountiful City at the finish.”
