

Respiratory Illness Report - Week ending February 1, 2025


Overview

Influenza: In Utah, influenza-associated hospitalizations increased slightly since last week and are now in the Moderate severity category. However, influenza-like illness (ILI) remains in Low severity. In Davis County, ILI activity is classified as Moderate severity.

COVID-19 Wastewater Surveillance: As of January 30, overall statewide viral concentrations of SARS-CoV-2 in wastewater have remained relatively stable across the state. There are four sites (11.4%) in the Elevated category, eight sites (22.9%) in the Watch category, and 23 sites (65.7%) in the Low or Very Low categories. In Davis County, the Central Davis site (Kaysville/Farmington/Fruit Heights area) and the South Davis – North site (Bountiful/Centerville/Woods Cross/West Bountiful area) are both in the Watch category. Influenza-Like Illness


Graph 1 displays the weekly percentage of outpatient visits due to influenza-like illness (ILI). For comparison, the dashed line shows the previous 5-year average (2019-2023) of ILI activity. This week's ILI rate was 5%.

School Absenteeism


Graph 2 displays the weekly percentage of elementary school absenteeism in Davis School District. For comparison, the dashed line shows the absenteeism rate of the previous 5 school years (school years beginning 2019-2023). Absenteeism data is currently unavailable.

Emergency Department Visits

Graph 3 displays the rolling 7 day average of the percent of emergency department (ED) visits due to COVID-19, influenza, and respiratory syncytial virus (RSV). These data are obtained from syndromic surveillance and only consider the diagnosis discharge codes for each condition. Table 1 presents two data points for each virus: the current trend of ED visits (increasing, decreasing, or no change), and the percent of ED visits due to each during the currently reported week.



Graph 3. Percent of ED Visits due to COVID-19, Influenza, & RSV, Rolling 7-day Average, Davis County, Utah



Virus	Trend	Percent of ED Visits
COVID-19	Decreasing (last 14 days)	0.3~%
Influenza	Increasing (last 14 days)	5.2~%
RSV	Increasing (last 7 days)	1.7 %
